Color samples must be submitted if the color is not on the approved color list OR are changing colors or you are using [Dunn Edwards Color-Ark® Pro](#) for D'Arcy Ranch.**
- 2. Architectural requests will be approved, denied and/or returned for additional information **within 30 days** after application receipt. **Project must start within 90 days of approval or you will have to resubmit application.** Response time is usually by the next meeting date but no more then 30 days, if ALL information REQUIRED is provided.
- 3. The Homeowner is referred to Section 14 of the D'Arcy Ranch Homeowner's Association [CC&R's](#) and the [Rules and Regulations](#). **Project must be complete within 90 days of actual start date.**
- 4. The Homeowner agrees to maintain the improvement if approved by the Board of Directors and/or the Architectural Review Committee. If in the view of the Board of Directors and/or the Architectural Review Committee the improvement is not being maintained, the Association has the right to maintain the improvement with the homeowner bearing all cost thereof or the improvement must be removed.
- 5. **The Homeowner agrees to comply with all City and State laws and to obtain all necessary permits. CC&R's 14.3 pg. 29 Building permits are obtained from the City of Chandler. 480-782-3000**
